### RELEASE FORM

Vaccination for rabies within 3 years is required for dogs. We require Bordetella for kennel cough. We retain the right to refuse service to any dogs not vaccinated. **Flea preventative is required.** If infested upon arrival to the kennel, your dogs will be bathed and treated for fleas/ticks at the owner's expense of a **minimum of \$50.00.** If the state of your dogs health requires veterinary care, we reserve the right to call a veterinarian, or administer minor first aid at our discretion and at the owner's expense. **We will attempt to call you if we have any problems.**

The maximum of \$ \_\_\_\_\_ may be spent in case of a serious emergency.

All dogs are boarded without liability on our part for loss or damage from disease, death, running away, theft, fire, injury to persons, injury to or by other dogs, or injury to property by said dog, or other unavoidable causes (lighting, snake bite & other acts of God, etc). We retain the right to refuse service to destructive dogs (that chew gating, hoses, wood, or kennel doors). We agree to exercise due and reasonable care to keep our kennels premises sanitary and properly enclosed. Your dogs will be fed regularly and will be housed in clean, safe quarters. Your dogs will not be taken off the premises except by the consent of the owner, or at **our discretion in case of a serious emergency and must be taken to a veterinarian.** The owner agrees to pay for all services rendered by this facility. Charges for boarding will be in one day increments, starting when your dogs are dropped off and ceases when they are picked up. Payment in full must be made during pick up, unless other wise noted. Dogs not claimed within 7 days of scheduled pick up will be dealt with at our discretion. The owner agrees to pay all legal fees necessary to collect pet care expenses.

The signing of this contract denotes blanket consent for any & all times our boarding is provided to your dogs.
